

Woonsocket Harris Public Library Liability Waiver & Release

NOTICE: Please read this entire Waiver carefully before signing. By signing this Waiver, you give up certain legal rights.

In consideration of the services provided by Woonsocket Harris Public Library (WHPL) I, an adult participant, or parent or legal guardian (Parent) of a minor (individual less than 18 years old) participant, for myself and on behalf of the minor, acknowledge and agree as follows:

Activities. Activities offered by WHPL include cooking program, STEAM programs, gaming activities, arts and craft projects and other instruction. Participation in these activities may require the use of scissors, knives, hot appliances, glue, hazardous liquids and chemicals, sharp tools and objects, small tools and objects, heavy objects, paint, markers, pencils, painting tools, papers, hot glue guns, dangerous equipment, fabrics, plastics, rulers, staples and fasteners, pins and needles, flammable liquids and materials, and various other items not named here.

Activities may occur on City of Woonsocket RI property at the library and other city public property such as local parks.

Risks & Assumption of Risks. I understand and acknowledge that there are dangers and risks involved in participating in activities offered by WHPL, or by being in the vicinity of activities offered by WHPL, that have the potential to cause physical injury or damage or loss of property. The risks listed in this Waiver are not exhaustive. Other risks may exist. WHPL will make every effort to ensure the safety of you and/or your minor child but cannot guarantee your child's safety or eliminate any of these risks. If I am the Parent of a minor participant, I have discussed the risks with the minor participant, who understands and accepts them. Participant is voluntarily participating with knowledge of the risks. Participant (and the Parent of a minor) assumes and accepts full responsibility for participant, for the inherent and other risks of these activities (both known and unknown) and for any injury, damage, or other loss suffered by participant (and the parent of a minor), resulting from those risks, including the risk of participant's own negligence or other misconduct.

Release and Indemnity. I WAIVE, RELEASE, DISCHARGE, and HOLD HARMLESS from any and all liability, from known and unknown health issues and any activities related to gaming system use, the following entities or persons: The Woonsocket Harris Public Library, the City of Woonsocket RI, Ocean State Libraries System and/or their directors, officers, employees, volunteers, representatives, and agents, activity holders, sponsors, and volunteers. I acknowledge that the above entities or persons are not responsible for the errors, acts, omissions, or failures to act of any party or entity conducting a specific activity on their behalf.

I hereby consent, or give consent for my minor child/dependent, and assume all financial costs to receive medical treatment which may be deemed advisable in the event of injury, accident, and/or illness during this activity. Immediate efforts to contact parent/guardian will be taken.

While participating in this activity, I, or my minor child/dependent, may be photographed for social media publicity. I agree to allow photos, video, or film likeness to be used for any legitimate library purpose. Participants may be identified by first name or initials only. No compensation will be given.

This Wavier is effective in regard to participant's enrollment or participation in all activities from the date signed until a subsequent Waiver is signed by participant or participant's parent and shall remain in full force and effect for all activities participated in by participant up until that point.

I agree to the Liability Waiver & Release. I certify that I have read this document CERTIFY THAT I HAVE READ THIS DOCUMENT IN ITS ENTIRETY AND I FULLY UNDERSTAND ITS CONTENT. I AM AWARE THAT THIS IS A RELEASE OF LIABILITY AND A CONTRACT AND I SIGN IT OF MY OWN FREE WILL.

If participant is a child age under age 18 years, Parent or Legal Guardian MUST SIGN. By signing, I certify that I have discussed the warnings and precautions with my child or dependent.
